An additional deposit of \$1,500.00 shall be made whenever the engineer’s review costs have depleted the deposited amount to \$500.00 or less. Following the approval of the application any remaining funds shall be returned to the applicant. **No application may be approved, issued, or recorded until all outstanding fees have been paid.**
